We provide person-centered training and support in technology, vocational, life and social skills. Our goal is to help each adult with autism in the program find their passion and reach their full potential. nonPareil has a proven track record of assisting this underserved group of people and successfully preparing them for increased independence and fulfilling lives. Some are able to pursue employment at nonPareil upon completion of their training. Others wish to pursue or return to college, while many transition into meaningful employment upon leaving nonPareil. During 2018, nonPareil provided services to 273 adults with autism.

Form 990, Part VI, Section B, Line 15 - The Board has a Compensation Committee composed of independent board members. The Compensation Committee reviews published data on comparable compensation, taking into account that nonPareil is a nonprofit dealing with adults with autism and technology, teaching adults with autism how to create technology products for the marketplace. As a result, certain employees will need to have appropriate background in related technology industries in order to train adults with autism, supervise the production of software and develop the technology level of these adults with autism so that they can participate in marketable projects. The Compensation Committee reviews comparable data from the technology industry, as appropriate, as well as data from the nonprofit industry, and brings a summary of its reviews and its recommendations to the full Board. The employee in question is absent from portions of the board meeting during which there is a discussion and/or vote regarding compensation. There is contemporaneous substantiation of the Board discussion and decisions. In 2014, the above procedure was used to set the compensation of the then-CEO and President. Their compensation did not change through 2018, apart from decisions regarding the Separation Agreement and General Release and the Consulting Agreement for former CEO William Selec in 2018. In that case, the Compensation Committee consulted with outside professionals in addition to its usual procedures before bringing recommendations to the Board, and the normal Compensation procedures were followed. In 2016, nonPareil hired a Vice President, Advancement, who was not a member of the Board. The position was approved by the full Board, with the discussion of comparable salaries and salary negotiations with this new employee discussed and approved by the executive committee of the Board. The Vice President, Advancement resigned in 2018. In 2017 the Director of Operations for Houston was promoted to Vice President of Operations, Houston. However, no salary adjustment was made at the time of promotion; thus, there was not a Board review of the salary already in effect.

Form 990, Part VI, Section C, Line 19 - Financial statements for nonPareil Institute are available on the website, as well as the most recently filed Form 990. Governing documents and the conflict of interest policy are available upon request.

Form 990, Part VII, Section A, Line 1a - William D Selec II resigned as Chief Executive Office and Director effective Feb 28, 2018. His reported compensation is in compliance with two governing documents: the Separation Agreement and General Release, with an effective date of Feb 28, 2018 between Selec and nonPareil Institute, and the Consulting Agreement in force from Mar 1, 2018 through Dec 31, 2018 between Selec and nonPareil Institute. Margaret Weinkauf resigned as Vice President, Advancement effective Feb 9, 2018. Average hours worked by Selec and Weinkauf as reported here takes their resignations early in the year into account.
